OVERVIEW

Aran partnered with Folkestone and Hythe District Council (FHDC) to deliver a large-scale, whole-house retrofit project under the Social Housing Decarbonisation Fund (SHDF) Wave 2.1.

The goal was to improve the energy efficiency and comfort of over 200 properties, reduce their carbon emissions and support FHDC's journey towards achieving their climate change and net zero targets. All measures were delivered in full compliance with PAS2030:2019 standards and Trustmark requirements. This project not only delivered measurable energy efficiency gains and tenant satisfaction but also strengthened local supply chains and embedded social values throughout.

Planning requirements were carefully managed, and health and safety compliance remained a priority throughout. Risks such as material supply delays and labour consistency were proactively mitigated through close collaboration with our manufacturing partners, long-term supply chain agreements and strong local recruitment strategies - ensuring both delivery resilience and community benefit.
